NOTICE OF RACE

"The regatta activities must be carried out in accordance with the provisions on combating and containing the spread of COVID 19 issued by the Federation that the Organizing Committees will activate and to which the participating members must comply under the supervision of the Organizing Committee itself. Any cases of COVID 19 that may be detected during the event will be reported by the Organizing Committee to the competent health bodies in charge."

Annotations:

[DP] the penalty for an infringement of this rule may, at the discretion of the protest committee, be less than the disqualification.

[NP] infringement of this rule cannot be protested by a boat (changing of RRS 60.1(a))

2. VENUE AND SCHEDULE:

Villaggio del Pescatore - Società Nautica Laguna.

The Championship will be held in Panzano Bay according to this schedule:

Friday	27 th	August 2021	Registration from 9:00 to 12:00
Friday	27 th	August 2021	Races, First Warning Signal at 13:00
Saturday	28 th	August 2021	Races
Sunday	29	August 2021	Races and Prize Giving

The Warning Signal of the following races of the 28th and 29th will be scheduled by official notice posted on the official board before 8 p.m of the 27th. If not the time of the previous day will be in force.

On the last day of the regatta no Warning Signal will be made after 4 p.m..

3. RULES:

The race will have the application of these regulations:

3.1 Rules as defined in the World Racing Rules Sailing 2021/2024 (RRS)

3.2 The Requirements of the National Authority (FIV)

3.3 "PROTOCOL FOR THE REGULATION OF MEASURES FOR THE CONTRAST AND CONTAINMENT OF THE SPREAD OF COVID-19 IN AFFILIATED SPORTS COMPANIES AND ASSOCIATIONS", current version – hereinafter referred to as "PROTOCOL". The penalty for an infringement of the "Protocol" can be a maximum of 10%, depending on the seriousness of the infringement committed. The percentage will be calculated on the position of arrival of the boat in the day race in which the infringement was committed, or using to the position acquired in the closest race when the infringement was committed.

3.4 The Notice Of Race, Instructions and Rules issued during the regatta. In case of conflict Instructions and Rules and following Official Communication will prevail (change RRS 63.7).

3.5 RRS Appendix P will apply (Rules 42 Special Procedure).

3.6 Europe Class Rules

3.7 Add to the rule 61.1 (a):” The Protestant boat must inform the Race Committee about the identity of the boat (s) that intends to protest on the finish line immediately after finishing”.

4. ADVERTISING [DP] [NP]:

Advertising is free as per Class rules and in compliance with Regulation 20 WS. Boats may be required to display advertising chosen or provided by the Organizing Authority within the limits set by Regulation 20 WS. Boats displaying individual advertising must be in possession of a valid FIV license and present it to the Race Secretary upon completion of the registration.

5. ELIGIBILITY:

The regatta is open to all boats of the Europe class according to the Rules for National Sports Activities Organized in Italy. Italian competitors shall follow the FIV racing license regulation for competitors for the current year, with the required health requirements and with the Class Association. Foreign competitors must comply with all rules provided by their National Authorities about sailing licenses.

6. ENTRIES:

Entries must be submitted and paid no later than the 20th August 2021 and shall be done through:

- A) APP MyFedervela or
- B) by completing the form that can be downloaded from the site www.nauticalaguna.it and available in the Società Nautica Laguna Office. The completed and signed form must be sent to info@nauticalaguna.it attaching the following documentation in a single e-mail:
 - ✓ Receipt of the registration fee;
 - ✓ Measurement Certificate;
 - ✓ Valid third-party liability insurance with a minimum cover according to FIV for the 2021 National Sports Activity Organized in Italy (not requested for competitor owning FIV Plus);
 - ✓ Advertising FIV license (if it occurs).
- C) Foreign competitors: entry form shall be send to info@nauticalaguna.it (specifying helmsman's name and surname and sail number) before the 20th Agosto 2021, entry fee must be paid before the 20th August 2021 too.

(the bank transfer shall clearly indicate europa regatta, skipper's name and surname, sail number, Yacht club name) In the case of a single bank transfer for several boats, indicate the sail numbers of all the boats.

Late entries will be accepted under the following conditions: extra fee of 50% according to FIV regulations.

Upon completion of the registration, those who have registered via the APP or sent all the required documentation in a single email to the above-mentioned address will have no other documentation to submit.

It will not be necessary to sign the release form, acceptance of the privacy policy and transfer of photo and video rights of the event.

At the time of regularization of the Entries, competitors must indicate their category (Legend, Super Master, Grand Master, Female, Junior).

In case of incomplete / unreadable / unsuitable documentation or in case of expired medical examination, supplementary or replacement documentation are requested at the time of completing the registration; competitors under 18 years of age shall present a signed and completed parent (or guardian) consent and declaration form at registration according to rule 4.1(b)

7. INSURANCE:

Each participating boat shall be insured with a valid third-party liability insurance with a minimum cover of 1.500.000 € according to D.1 FIV regulation or owning the FIV PLUS.

8. MEASUREMENT CONTROL [NP]:

Preventive measurement controls are not scheduled. Each boat (equipment and sails too) entered shall have a valid measurement certificate. In the event of damage, sails may only be substituted with the permission of the Race Committee after verification of the damage.

Measurement control could be done after every race.

9. RACES SCHEDULE:

9 races are scheduled with a maximum of 3 races per day on Friday and on Sunday. If the weather and sea conditions allow it, it will be possible to do 4 races on Saturday and 2 on Sunday, as indicated by the Europe Class.

3 races are required to be completed the Championship, 15 crews needed, according to current FIV Rules.

10. SCORING:

The Low Point Scoring system off RRS Appendix A will apply.

Discards:

- Up to 3 races no discards are allowed
- If 4 to 8 races are sailed one discard will be allowed
- If 9 races are sailed, two discards will be allowed

Final results will be drawn up on the basis of Annex "A" to the RRS and FIV Regulation results actually achieved in the races count, without purifying the results of any foreign crews.

11. SUPPORT BOATS [NP]:

All the supporters and trainers boats must get an accreditation at their arrival by filing the registration form available at the Race Secretariate declaring:

- 1) boat and boat engine features;
- 2) acceptance of the "rules for Coaches and assistance boats" described in the Sailing Instructions;
- 3) competitor's names supported.

All support boats will be required to comply with Sailing Instruction and with current Maritime Authority legislation who may revoke the permit to be present on the race course according to 64.5 RRS.

12. SAILING INSTRUCTIONS:

Sailing Instructions available on app MyFedervela and on web site from the day before the start of the regattas and, on demand, at the Secretariate club from 9:00 of the first racing day.

13. PRIZES:

Prizes will be given, at the end of the Championship, to the 3 best classified and to the first woman, to the first Grand Master (born in 1971 or before), to the first Super Master (born in 1961 or before), to the first Legend (born in 1951 or before) and to the first Junior (born in 2004 or after).

The Memorial Bruno Marsi Trofhy will be given to the first classified, to the first woman and to the youngest best classified. In addition, the first foreign competitor will be awarded. Other prizes will be given according to entries.

The Prize Giving Ceremony will be held as soon as possible at the end of the Championship.

14. DISCLAIMER OF LIABILITY:

Competitors participate at the regatta entirely at their own risk. See rule 4, Decision to Race.

It shall be the sole responsibility of the helmsman, or whoever takes his place, to decide whether or not to race or to continue the race. The Organizing Authority, the Race Committee and the Jury will not accept any liability for material damage or personal injury occurred before, during or after the races.

15. ECOLOGICAL MANAGER

The helmsman will be the "Ecological Manager" (R.Eco) in charge of promoting sustainable participation in the regatta in compliance with the decalogue attached to this Notice of Race, changing the RRS 4.4.

16. RIGHT TO USE NAME AND LIKENESS:

Competitors automatically grant to the Organizing Authority the right in perpetuity to make, use and show from time to time and at their discretion any motion pictures and live, taped or film television and other reproductions of him/her during the period of the competition.

17. BOATS, CAR AND TRAILER PARKING:

The boats will be admitted to the area indicated by the organizing club according to the instructions given by the staff.

18. EVENTS:

At the end of the regata on Friday 27th August, a barbeque will be managed at the "Punta" from 19:30.

On Saturday, it will be possible to dine at the Organizing Club at a special price.

The event will take place as part of the "*Mare Morje Sailing Un mare da vivere*" which will take place at Villaggio del Pescatore and in the municipal area of Duino - Aurisina.

The event will involve all activities related to the sea, the environment, the caves in the area to develop the themes of tourism, environment, sport, history, culture and volunteering.

19. ACCOMODATION:
